The welcome meeting and visit with USAID, FHI 360, and EpiC delegation on HIV in Cambodia

January 24th, 2025 | NCHADS Meeting Room | Phnom Penh | CAMBODIA



This welcome meeting had 35 participants, including representatives from UNAIDS HQ, FHI 360 HQ, and EpiC Consultants, representing a diverse set of expertise. **Prof. OUK Vichea**, Director of NCHADS, opened the meeting with welcome remarks, followed by a self-introduction of all the participants and delegations.

Purpose and productivity of the meeting:

Review PEPFAR strategies for HIV prevention in Cambodia, focusing on:

- Demand generation and Social and Behavior Change (SBC) strategies.
- Current progress of PrEP implementation.
- Opportunities for scaling up PrEP and improving retention while reducing dropout rates.

Review PrEP data systems, including:

- Challenges related to the interoperability between the PrEP database and other HIV databases.
- Monitoring and Evaluation (M&E) strategies for PrEP coverage and measuring person-years on PrEP.

Share best practices on:

• Models for PrEP expansion and choice counseling, including oral PrEP, vaginal ring, and CAB-LA.

Improve understanding of client preferences, focusing on:

- Identifying gaps and opportunities for scaling up engagement and prevention programs for Young Key Populations (YKP).
- Leveraging digital health tools for program engagement and implementation.

- Identify gaps in HIV prevention programs, particularly in the Prevention Program.
